A non-refundable bid deposit of **R500.00** will be charged for each document issued. All payments and deposits are to be made in the currency of the Republic of South Africa. Cash or bank-guaranteed cheques made out to Makhuduthamaga Local Municipality will be accepted. Completed and signed tender documents must be sealed in an envelope and **marked with the relevant project description** and be deposited in the tender box at Makhuduthamaga Local Municipality Offices in Jane Furse before the closing date and time. **Closing date and time for the submission of the tender documents is 22 of July 2014 at 12:00.**

The municipality shall adjudicate and award bids in accordance with the **Preferential Procurement Policy Framework Act, 5/2000** and revised regulation June 2011 on 100 points for functionality and 90/10 points system where 90 points are for the price and 10 points for BBBEE according to the said legislation. Details of Functionality are in the tender document. Bids will remain valid for 90 (ninety) days. The lowest and any tender will not necessarily be accepted and the Municipality reserves the right not to consider any tender not fully completed.
