All tenders will be adjudicated and awarded in accordance with the Preferential Procurement Policy Framework Act, 5/2000, on the above-mentioned points system where 90 and 80 points are for price and 10 and 20 points are for B-BBEE respectively, according to the said legislation. Tenderers are required to sign where necessary and initial every page of the tender document.

All tenders must remain valid for 90 (ninety) days.
