The Municipality will adjudicate and award tenders in accordance with the Preferential Procurement Policy Framework Act, 5/2000, on a 100 points functionality basis, and the 80/20 preference points system where 80 points will be allocated to price and 20 points to B-BBEE (according to said legislation). Tenders will remain valid for 90 (ninety) days.

The lowest or any tender will not necessarily be accepted and the Municipality reserves the right not to consider any tender not fully completed. Tenderers are required to initial each page of the tender document and sign where necessary.
