The Municipality shall adjudicate and award tenders in accordance with the Preferential Procurement Policy Framework Act 5/2000 and revised procurement regulation June 2011 on 100 points for functionality and 90/10 points system where 90 points are for the price and 10 points are for B-BBEE according to the said legislation. Details on functionality are in the Bid document. **Tenders will remain valid for 90(ninety) days.** The lowest and any tender will not necessarily be accepted and the Municipality reserves the right not to consider any tender not fully completed. Bidders are required to initial each page of the tender document and sign where necessary.
