CALL FOR NOMINATION OF CANDIDATES TO SERVE ON THE NKOMAZI SPECIAL ECONOMIC ZONE (SEZ) ENTITY BOARD

In terms of section 25(5) of the Special Economic Zones Act, 2014 (Act No. 16 of 2014) the Member of Executive Council (MEC) responsible for the Department of Economic Development and Tourism, **Ms. N E Hlope**, as a licensee, hereby call for nominations of individuals who will serve on the Nkomazi SEZ Entity Board.

The appointment shall be subject to section 25(5) of the Special Economic Zones Act, and must comply with the governance principles as set out in section 3 of the Special Economic Zones Governance and Management Regulations, which provides that licensee must:

- appoint not less than three and not more than ten persons with diverse skills, knowledge, experience and expertise relevant to Special Economic Zones as members of the Board;
- ensure that at least one member of the Board of the Special Economic Zone shall be a representative of the National Department responsible for Trade and Industries;
- ensure that the operator or representative of the Special Economic Zone Operator shall be an ex-officio member of the Board;
- appoint the Chairperson of the SEZ Entity Board from one of the members of the Board; and
- ensure the composition of the Board must be broadly representative on the grounds of race, gender and geographical regional representation, experience and expertise.

Please take further notice that in terms of section 6 of the Special Economic Zones Governance and Management Regulations, a person could be disqualified from being appointed as a Member of the SEZ Entity Board if such a person:

- is an un-rehabilitated insolvent;
- has been declared by a High Court with jurisdiction to be mentally ill;
- has been convicted of an offence-
 - In the Republic or elsewhere, other than an offence committed prior to 27 April 1994;
 - associated with a political objective and sentenced to imprisonment without the option of a fine; or
 - relating to fraudulent activities or any other offence involving dishonesty and sentenced to a fine or imprisonment, or both a fine and imprisonment;
- has at any time been removed from an office of trust on account of breach of fiduciary duties; or
- is otherwise disqualified in terms of section 69 of the Companies Act, 2008 (Act No. 71 of 2008).

All interested parties are invited to submit nominations within **21 days** as from the date of publication of this Notice. Confirmation of the availability of the nominee is also required.
