Bids are hereby invited from Contractors registered with the Construction Industry Development Board (CIDB) for the **Maintenance of Roads and Stormwater within Makhuduthamaga Municipality** in the Sekhukhune District as and when required for a maximum period of two years from the date of appointment.

The employer is the Makhuduthamaga Municipality represented by the Municipal Manager.

Prospective Bidders are requested to meet the employers' representative in the Council Chamber at Makhuduthamaga Municipal Offices at 10:00. Only contractors with **CIDB grading of, 7CE or higher** may Bid.
