**IMPLEMENTATION OF THE STREET ADVERTISING BY-LAWS AND THE APPROVED TARIFF
POLICY FOR THE 2023/24 FINANCIAL YEAR**

Notice is hereby given in terms of Section 21 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) to notify the public that the Municipality intends to fully implement the provisions of the Street Advertising By law, read together with the approved Tariff Policy for the 2023/24 Financial year, The implementation will be effective from 1st July 2023.

Members of the public are therefore notified that all the advertising boards and/or signs found to be erected within the jurisdictions of the Makhuduthamaga Local Municipality, shall be billed from 1st July 2023 in accordance with the approved Tariff policy for the 2023/24 Financial year. Members of the community are further advised to get approval from the Municipality for their street advertising. As a result, all street advertising materials/boards which are not approved by the Municipality and/or not paid for by the owner(s), they will be removed by the Municipality as from 1 July 2023.

The approved Tariff Policy for 2023/24 Financial Year and Makhuduthamaga Local Municipality Street Advertising By-law will be available for public perusal during normal office hours (08h00-16h30, Monday to Friday) in Municipal head office, located at No 1 Janefurse-Groblersdal Rd, office of Manager: Revenue and/or Senior Manager: Economic Development and Planning, or can be accessed 24hrs a day, from the Municipal website, www.makhuduthamaga.gov.za
