Quotations are hereby invited from Service providers for repair of Guard room at Jane Furse Landfill site

RE: SPECIFICATION FOR BUILDING OF TOILET AND REPAIR OF GUARDROOM AT JANE FURSE LANDFILL SITE.

Specification for Toilets

- Building pit toilet.
- Toilet with the depth of 2m & 2x2m wide.
- Building it with block brick and plaster it in and outside.
- Building a wall shelter in the front, Install 2 ventilation pipes.
- Install fascia boards.
- Paint IBR with maroon roof paint.
- Toilet should have 2 lockable steel doors labeled ladies & gents.

Specification for repairs of office

- Repair office roof and seal it with maroon paint
- Changing of six rafters measuring six metres.
- Replace 7.5m fascia board of the office
- Repair door handle of office (lever)

Specification for repairs of Guardroom

- Seal guardroom IBR with maroon roof paint measuring 3 square metre
- Repair door handle of guardroom (lever)

The employer is Makhuduthamaga Local Municipality represented by the Municipal Manager.

Completed and signed Quotations must be sealed in an envelope marked "**BUILDING OF TOILET AND REPAIR OF GUARDROOM AT JANE FURSE LANDFILL SITE**". The closing date is **Wednesday the 24th of April 2013 at 12:00** and should be deposited in the tender box at Makhuduthamaga Local Municipality Offices in Jane Furse.

Preference will be given to those who are registered with the Municipality's database as in terms of Section 13(i) of SCM Policy. The following documents must be submitted with the quotations: A valid tax clearance issued by SARS, Company registration, Company profile (attach appointment letters for the work done), Proof of payment of Municipal services (for both the company and the directors), Joint Venture Agreement (If any), and the certified ID copies of Directors.

Bidders are requested to attach their B-BBEE status level certificate. The certificate must be issued by SANAS accredited agencies or registered auditors approved by the Independent Regulatory Board of Auditors (IRBA). The Municipality has the right to check the validity of the certificate.

Note: All copies must be certified. The certification must not be older than three months of the closing date. Quotations must be accompanied by the Declaration of interest and MBD 9 forms as attached.



 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
