<ul style="list-style-type: none"><li>✓ Fumigation required for the following:</li><li>✓ Snakes and Rats</li><li>✓ Cockroaches</li><li>✓ Paper Moth</li><li>✓ Ants</li><li>✓ Termites</li><li>✓ Mould</li><li>✓ Insects</li><li>✓ The chemicals to be used must be SABS Approved, non-toxic and in a foam state where possible to avoid damage to papers and documents stored in the records department.</li><li>✓ The chemical must not be corrosive, caustic and damaging over any given time.</li><li>✓ A Material Safety Data Sheet of all chemicals to be used must be provided to the municipality.</li><li>✓ The fumigation must be conducted on a Friday to allow the smell to vanish until employees use the office on the following Monday.</li><li>✓ A service provider must be licensed and accredited with relevant pest control authorities who will issue a fumigation certificate upon completion.</li><li>✓ Required to conduct mini training on the cleaning process after fumigation to our cleaners to ensure their safety.</li></ul>
