NOTICE IN TERMS OF SECTION 116(3) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 (ACT 56 OF 2003) FOR THE AMENDMENT TO THE EXISTING APPOINTMENT OF NSK ELECTRICAL AND CONSULTATION MANAGERS (PTY) LTD FOR THE AWARDED CONTRACT No.: MLM473/MAMONE-ELEC/21/22/032 FOR THE ELECTRIFICATION OF 295 HOUSEHOLDS AT MAMONE VILLAGE

Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Makhuduthamaga Municipality to amend the existing contract: Number: MLM473/MAMONE-ELEC/21/22/032: NSK ELECTRICAL AND CONSULTATION MANAGERS (PTY) LTD FOR THE AWARDED CONTRACT No.: MLM473/MAMONE-ELEC/21/22/032 FOR THE ELECTRIFICATION OF 295 HOUSEHOLDS AT MAMONE VILLAGES

Reasons for the proposed amendment: The municipality secured the appointment of NSK Electrical and Consultation managers (Pty) ltd for the electrification of 395 households at Mamone villages for 2021/22 financial year projects on a Turn-Key form of contract. The final design depict 820 households as opposed to 395 households planned with a variance of 425 households. Currently the project has been put on hold due to community dissatisfaction towards the number of households planned to be electrified. The 425 households were earmarked to be electrified next financial year as Phase 2 of the current project with procurement process completed this financial year. Even so, the latest letter from National Treasury related to Preferential Procurement Regulation, 2017 prohibit advertisement of tenders. The implementation of the abovementioned section will allow the municipality to electrify the 425 household this financial year. Notice is hereby further given in terms of Section 21 and 21A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) that the local community and interested / affected parties are invited to submit comments or representations to the Municipality in respect of the above, such comments or representations must be received within 14 days of advertisement via electronic mail to the e-mail address provided below, or be delivered to the undersigned to the mailing address provided hereunder. ## **21A.** Documents to be made public

(1) All documents that must be made public by a municipality in terms of a requirement of this Act, the Municipal Finance Management Act or other applicable legislation, must be conveyed to the local community—

(a) by displaying the documents at the municipality's head and satellite offices and libraries;

(b) by displaying the documents on the municipality's official website, if the municipality has a website as envisaged by section 21B; and

(c) by notifying the local community, in accordance with section 21, of the place, including the website address, where detailed particulars concerning the documents can be obtained.

(2) If appropriate, any notification in terms of subsection (1)(c) must invite the local community to submit written comments or representations to the municipality in respect of the relevant documents.

## **21B. Official website**

(1) Each municipality must-

(a) establish its own official website if the municipality decides that it is affordable; and

(b) place on that official website information required to be made public in terms of this Act and the Municipal Finance Management Act.

(2) If a municipality decides that it is not affordable for it to establish its own official website, it must provide the information in terms of legislation referred to in subsection (1)(b) for display on an organised local government website sponsored or facilitated by the National Treasury.

(3) The municipal manager must maintain and regularly update the municipality's official website, if in existence, or provide the relevant information as required by subsection (2).
