**1. STRATEGIC THRUST**

To promote sound financial management and viable financial management including good governance

**2. PURPOSE OF THE REPORT**

The purpose of the report may be to provide the management and Council with the progress regarding the implementation of the supply chain management system for the second quarter ending 31 December 2015

**3. BACKGROUND**

Section 6 (2) and (3) of the MFMA Municipal Supply Chain Management Regulations requires that for the purpose of Council to exercise its oversight role and the accounting officer must monitor and assess on continuous basis the implementation of the Supply Chain Management System and submit a report on the implementation at the end of each quarter to the Executive Mayor

The report is submitted to ensure that the supply chain processes followed by management is in line with government policy framework and regulations pertaining to supply chain management. And the upkeep of the objectives as outlined in the municipal supply chain policy

The information used in reporting of contracts awarded during the second quarter of 2015 / 16 financial year. All bids contained in this report were advertised, evaluated and adjudicated in accordance with the Supply Chain Policy and is obtained from the appointment letters signed by the Accounting Officer

Overall companies with women ownership were awarded the total of five bids out of eighteen which equal 27.77% of the total bids awarded; local companies were awarded 15 bids out of the eighteen which equals 83.33% of total bids awarded

The bids awarded above R100 000 were eighteen in total for the quarter two of those were meter readings appointed on price per rate, and Rustenburg Local Municipality annual family extravaganza appointed at own risk (to source own funds). Sixteen bids were awarded on fixed prices to the amount of R 170 983 473.62 from which 83.33% was awarded to local companies to the amount of R 104 610 372.10
