1. CRITERIA FOR THE AWARDING OF CONTRACTS

According to the Preferential Procurement Framework Act and Regulations a preference point system must be followed:

1.1 The 80/20 Preference Point System

Organs of state may, however, apply this formula for procurement with a value less than R30 000, if and when appropriate:
