Application for the Commodity Clearance of genetically modified maize

Corteva Agriscience RSA (Pty) Ltd, P.O. Box 8010, Centurion 0046; hereby informs the public about its intention to submit an application for the commodity clearance of grain and derived products obtained from DAS1131 maize into the environment of South Africa.

DAS1131 maize was genetically modified to produce the Cry1Da2 protein for protection against certain susceptible lepidopteran pests and the DGT-28 EPSPS protein for tolerance to glyphosate herbicide.

The Cry1Da2 protein is encoded by the *cry1Da2* gene, a chimeric gene comprised of sequences from the *cry1Da2* gene encoding an insecticidal core toxin and a derivative of the *cry1Ab* gene, both derived from *Bacillus thuringiensis* (*Bt*). The expressed Cry1Da2 protein binds to receptors in the brush border membrane of certain susceptible lepidopteran pests and causes cell death through the formation of non specific, ion conducting pores in the apical membrane of the midgut epithelial cells.

The DGT-28 EPSPS protein is encoded by the *dgt-28 epsps* (5-enolpyruvylshikimate-3-phosphate synthase) gene derived from *Streptomyces svicens*, fused to a chimeric chloroplast transit peptide, TraP8, from *Brassica napus* and *Brassica rapa*. The expressed DGT-28 EPSPS protein is targeted to the maize chloroplasts through the TraP8 peptide to provide tolerance to glyphosate herbicide.

DAS1131 maize derived-products may be used throughout the Republic of South Africa in foods, animal feed and industrial products. This is not an application for cultivation or release into the environment. Imported commodity grain may possibly be commingled with conventional maize.
