RESOLUTION ON: 2018/19 ADJUSTED BUDGET 2018/19

NOTING THAT:

- 1. In terms of the Local Government Municipal Finance Management Act 56 of 2003 Section 28(2)(a)(b)(c)(d)(e)(f)(g), a municipality may revise an approved annual budget through an adjustment budget. In terms of the Local Government Budget & Reporting Regulations 23, an adjustment budget referred to in section 28(2) of the Act may be tabled in the municipal council at any time after the mid-year budget and performance assessment has been tabled in council, but not later than the 28th of February in the current financial year.
- 2. The annual budgeted revenue for the 2018/19 financial year remained at R 406 million, however there is an increase of R 1 thousand rand which is a net effect of the budget adjustments to various revenue items as approved by council. The approved cash backed reserves budget has increased from R 16.4 million to R 40.4 million for the 2018/19 financial year.

The total annual budgeted expenditure for 2018/19 has increased from R 422.5 million to R 446 million. The total approved operational budget has increased from R 318 million to R 343 million and the total approved capital budget has decreased from R 104 million to R 102 million for the 2018/19 financial year as set out in the following supporting tables:
