- 2. The annual budgeted revenue for the 2022/23 financial year has been adjusted from R474, 5 Million to R477, 6 million.

The annual budgeted operational expenditure for 2022/23 has moved from R 374, 9 million to R 406, 5 million.

The capital expenditure has been adjusted from R 188, 5 million to R189 million.

The budgeted expenditure in excess of the budgeted revenue will be funded by cashback reserves to a total amount of R 118 million.
