#### **NOTING THAT:**

1. In terms of the Local Government Municipal Finance Management Act 56 of 2003 Section 28(2)(b), the municipality may appropriate additional revenues that have become available over and above those anticipated in the annual budget but only to revise and accelerate spending programs already budgeted for.

2.

- 2.1 The annual budgeted revenue for the financial year 2017/18 was adjusted from R 391 million to R 405 million during the first budget adjustment period for 2017/18 financial year. The annual budgeted revenue has been adjusted further to R 410 million during the second budget adjustment period having taken into consideration the additional revenues which became available during the year. Cash backed reserves to the amount of R 28 million were adjusted to R 36 million to fund the expenditure in excess of budgeted revenue for the 2017/18 financial year.
- 2.2 The total annual budgeted expenditure for 2017/18 was adjusted from R 414 million to R 477 million during the first budget adjustment period of the 2017/18 financial year. The total annual budgeted expenditure was further adjusted to R 488 million during the second budget adjustment period of the 2017/18 financial year.
- 2.3 The Operational Expenditure for 2017/18 was adjusted from R 269 million to R 327 million during the first budget adjustment period and no further budget adjustments were made on the total operational budget for 2017/18 financial year.
