Purpose

The purpose of this is to procure 15 x 25L of ERGOFITO MICRO MIX AQUA + BIO FLUSH and 16 - 20 L/kg chemical mix container (Plastic) with spray.

Background

Sewerage is generated from household with different sizes and contents. Fats amongst other matter accumulate and solidifies inside the sewer line and manholes causing blockages and overflows. The fats has a potential to damage the honey system and that of enhances pump clogging. It is then advisable to have to have this safe and healthy environmental friendly chemical.

Discussion

The ergo-fito chemical dissolves the sludge and fats within the sewer lines. this chemical also reduces the smell of sewer and that it reduces flyes and mosquitoes. the chemical is also used to reduce the sludge within the treatment works.

This chemical was used before and yielded good results on the spilled area, as part of remedial action to huge and small affected area.

Motivation

The smell of sewer is a hazard by nature. During the unblocking of sewer lines, fats are found to be present in many cases. Fats has a tendency to disturb the flow and cause the sewer to overflow. In all cases of sewer overflows, this chemical can be used to kill germs and smell of that area.
