- 1.1 Guardrails, end wings, all bolts, nuts, washers and reinforcement plate must comply in all aspects with the requirements of SABS 1350 of 1982.

The below mentioned are requirements on specification:

- a) Rails shall have 3 slotted holes spaced at 1905mm canters
- b) End wings must be of bullnose type
- c) The Post bolts are 400mm and 600 mm Diameter. The thread length of bolts shall be 75mm
- d) Bolts may be supplied with either hexagonal unit with washers or recessed nuts.
- e) Spacer blocks (360mmx100mmx50mm) pine or Eucalyptus planks treated separately with tanalith.
- f) Guardrails and bullnose shall be galvanized.
- g) All timber posts and spacer block for Guardrails to comply with SABS 457.
- h) Treatment must be carried out after cutting, drilling and shaping.
- i) V-Shaped reflector plates shall be manufactured from mild steel plate of nominal thickness 1.5mm.
