#### **TERMS OF REFERENCE**

Lephalale Local Municipality currently consist of one honey sucker which is servicing town and villages in terms of sucking out sewer at pump station and septic tanks. The honey sucker that is currently in use is characterized by constant breakdown which lead to sewer overflow in and around Lephalale town.

The pumping out of sewer in various areas has in the past been done by a service provider when the honey sucker went for repairs. Since the availability of the new honey sucker cannot be determined as the division is waiting for delivery, there is a need to have a contingency plan. The division requires the service of a company with the following specification:

- 1. Pumping out of sewer will be done as and when required by the municipality.
- 2. Service provider will only provide service only when requested by the designated municipal official.
- 3. The company must have a licence with the municipality for dumping of sewer in the authorized area.
- 4. The service provider must attach proof of payment of their dumping manifest to the municipal account.
- 5. Service provider must have capacity to pump out sewer at various areas including pump stations.
- 6. The service provider must charge rate per litre inclusive of transportation to authorised dumping site.


