RE-CONSTRUCTION OF DOUBLE WALL AND INSTALLATION OF PALISADE FENCE AT 7 GRUISWEG STREET AS PER SPECIFICATION.

BACKGROUND

The Sanitation Division has worked on a pipe burst at Gruisweg no 7 where a 200m pipe was replaced. The pipeline servitude was running through the yard and parallel to a fence wall feeding to pump station 1. During excavation the wall collapsed. This was channelled by major sewer pipe burst along the Gruisweg no & yard which needed urgent attention.

<u>NOTES</u>

- The minimum concrete strength required is 25MPA.
- The pricing must include all the material e;g Purchasing of face brick that match existing brick, palisades and travelling cost.
- The Service provider is expected to have his own Personnel, tools and equipment's (e.g concrete mixer/ usage of ready mixer concrete, water tanker including water, Generator, compactor roller e.t.c) that will enable him/her to build a wall, install palisade fencing and palisade gate.
